REGENTS REPORT

- Superintendent Retz reviewed the January 2014 Regents Report prepared by Mr. Walters, Executive Principal 6-12. The results were similar to last year. All Juniors take the ELA Regents in January to help alleviate the number of regents they have to take in June. All Juniors will also have to take the ELA Common Core exam at the beginning of June.

BUDGET COMMITTEE UPDATE

- Mark Rubitski, Business Manager, reviewed with the Board the line items reviewed by the Budget Committee to-date.

 The Committee recently reviewed line item amounts for retirement, Social Security, unemployment, medicade/medicare, health insurance and capital projects. ERS has leveled off, but TRS continues to increase. Health insurance will increase 10.8% or approximately \$300,000 next year. The committee is hoping to get through all remaining line items at their meeting next week.
- Mark Rubitski reported on a recent Health Insurance
 Consortium meeting that he and Board member, Ethan Day, attended. As mentioned above, Greene's rate for next year will be 10.8% for 2014-2015, which is lower than previously projected. Mr. Rubtiski explained that the rates are based on use. Two years ago Greene's expenses exceeded revenue by 17%. Instead of making up the 17% all in one year, pay back increases were spread over 3 years, having less of an impact on the district. This is an advantage of being in a consortium where expenses can be absorbed and paid back over time.

- After a review of information and discussion, the Board decided not to offer the Alternative Veterans' Exemption at this time.

The board can reconsider the exemption again next year.
