SUPERINTENDENT'S REPORT:

- Superintendent Timothy Calice reported on the following:

- Health Insurance Consortium BlueCross BlueShield offers tools to help districts with cost savings through that staff and the district can utilize, but may not be aware of. He is working with Mark Rubitski, Business Manager, and the GTA to find a time in November to have a representative present this information to district staff.
- Board Policies A concern as to what happened to other than required policies when the district Policy Manual was revamped was raised. A policy was found which was not in the approved policy manual group which did not have a number. Whether or not all old policies were deleted is being questioned. A review of all approved policies and any old still valid policies which were not included may need to be reviewed by the Policy Committee and readopted by the Board.
- New Bell Schedule The new bell schedule has been updated in the student management system for attendance purposes and Syracuse Alarm will be reprograming the bell schedule soon. The changes made will get us through this year and then a committee will review the changes for any needed "tweaks" before the start of next year.
