- Ms. Wells stated that Tim Paske was supporting his team and their vote to not march in the homecoming parade.

**WES MOORE** 

- Mr. Moore stated that it is not unusual for teams to not want to break their pre-game rituals. He also stated that he felt the school district had more important things to deal with than this issue.

**TAYLOR NOELLE** 

- Mrs. Noelle stated that her son, Chad Noelle, would not be in Oregon training for the Olympics if it were not for Tim Paske's support and help.

**DAVE SPEAR** 

- Mr. Spear read a letter received from his son, Kurt Spear, in support of Tim Paske.

**JEAN HASKELL** 

- Mrs. Haskell questioned why the parade is held at 4:30 p.m. on a Friday when so many parents do not work in Greene and have a difficult time getting there in time to support their students. Having the parade on a Saturday morning would allow more parents and community members to be involved.

**CHRIS KEHOE** 

- Senior football player Chris Kehoe stated that it was a vote of the football team that decided whether they would participate in the parade or not. The team chose to focus on their upcoming game and Mr. Paske supported and defended their decision.

DAN ERICKSON

- Mr. Erickson stated that he had spoke to 6 out of 7 Board members the night the decision to suspend Mr. Paske was made and they indicated that they did not have any information. He stated that this was an opportunity to bring the community together.

**BERNIE MCDERMOTT** 

- Mr. McDermott thanked the audience for their support of Tim Paske and stated that he believed the entire homecoming process needed to be reviewed.
