BUSINESS & FINANCE:

 Mark Rubitski, Business Manager, reviewed the budget **BUDGET COMMITTEE** planning documents with the Board. The Budget Committee has reviewed all budget line items and set preliminary budgets. There are still ongoing discussions regarding programs, BOCES budgets, and state aid which will affect the final budget numbers.

The goal is to present a final budget for Board approval on April 2nd. As the budget figures stand right now, the proposed budget shows an increase of 0.77%, or \$187,009.

Mr. Rubitski also shared the property tax cap calculations. Based on Greene's allowed adjustments, our tax cap limit will be 2,98% with a simple majority vote. Last year it figured out to be 2.85%.

Using estimates for state aid, current budget figures, and a 1.46% (current CPI) tax levy increase Greene will have a \$840,984 shortfall. As in the past, to balance the budget, the district can increase the tax levy, use reserves, further cost saving adjustments, or any combination of the three.

The Budget Committee will make recommendations for the Board's final review.

SUPERINTENDENT'S REPORT

- Superintendent, Jonathan Retz, reported on the following:

- 1. NYS Wrestling Championship Congratulations to Christian Dietrich, a sophomore, who won the NYS Division II State Wrestling Championship at 182 pounds on March 1st. Christian did not give up any points in his state championship matches and only 4 points all season. There is a nice article on the web page.
- 2. NYSCOSS Conference Superintendent Retz thanked the Board for allowing him to attend the NYSCOSS conference. Superintendent Retz heard from the Commissioner and was able to attend several valuable break-out sessions.
- 3. Lobby Day Superintendent Retz had dinner with representative Clifford Crouch and had a good discussion on the needs of rural school districts. There is talk of a Senate proposal to phase out the gap elimination adjustment over the next two years. Legislators are pushing for additional money for schools, but details have not been finalized.
- 4. Possible Capital Project Together with administrators, a preliminary list has been developed and shared with Tetra Tech architects and engineers. A 7-9 million dollar capital project is possible with no local tax levy impact. The preliminary list includes roof repairs, paving parking lots, technology, and other building specific needs. The preliminary list will be sent to the Buildings & Grounds Committee for their review.

PUBLIC COMMENT: CONNER GRANT

- Conner Grant, 6th grade student, asked what "second" on a motion was.

PRESIDENT BOELTZ

- President Boeltz explained that the Board follows parliamentary procedures when dealing with business issues. A motion and a second indicates that there is enough interest among Board members to proceed with discussion and a vote.

JAKOB FUNNELL

- Jakob Funnell, 6th grade student, stated that he had heard a rumor that Raymond was buying the school.

SUPT. RETZ

- Superintendent Retz stated that Raymond's need is for parking space. They did rent classroom space from us at the beginning of the school year while they were completing a building renovation. But they are not interested in buying the school.
- Jakob Funnell also asked why the Board has meetings.

VICE-PRESIDENT DAY - Vice-President Day answered that the Board makes the big decisions for the entire school. Board meetings are subject to open government laws and anyone can attend meetings.
